## OFFICE MEMORANDUM

Subject:- Policy for providing 'Compassionate Employment' and delegation of Powers to department(s) for disposal of cases of compassionate appointments.

1. A "Revised Policy for providing 'Compassionate Employment' and also delegation of Powers to department(s) for disposal" was framed/circulated vide this Department's OFFICE MEMORANDUM of even number dated 07.03.2019. In partial modification of it, the Para-12 - "HOW TO ASSESS INDIGENCY" shall deem to have been amended w.e.f. 07.03.2019 i. e. from the date of issuance of the revised policy as below:-

> "12) <u>HOW TO ASSESS INDIGENCY:-</u> Indigency means a level of poverty in which real hardship and deprivation is suffered and the comforts of life are wholly lacking. Following criteria shall be adopted to assess indigency of the family of the deceased Government employee while examining compassionate cases:-

Income Criteria will be an important criteria to determine indigency. The maximum ceiling of total family income to assess indigency is fixed as Rs. 2,50,000/-, presuming a family of 04 persons. Even if the number of family persons exceeds 04, the family size will still be presumed to be 04. If the family members are less than 04, then income of the family would be calculated by multiplying Rs. 62,500/- by the number of family members. Thus, if the family size is 03, the maximum income limit would be Rs. 1,87,500/- per annum to determine indigency. If family size is 02, the income limit would be Rs. 1,25,000/- per annum to determine indigency. The above income criteria has been mentioned to bring objectivity in the determination of indigency of a family/applicant."

2. The above amendment may be brought to the notice all concerned for information and strict compliance.
