Eligibility for recruitment.	4.	A. candidate shall be eligible for appointment to Class III post(s), if he/she has passed Matriculation and 10+2 and for Class IV post(s), if he/she has passed Middle or Matriculation from any School/Institution situated within Himachal Pradesh: Provided this condition shall not apply to Bonafide Himachalis.
