## OFFICE ORDER

Whereas, Sh. Sanjeev Kapoor S/O K.L. Kapoor R/O Kapoor Bhawan Totu Shimla Tehsil & Distt. Shimla H.P. has been enlisted as class "A" Contractor with HP PWD, vide Office Order No. Pw/-CTR-32-2 (2)/2012-39810-910 dated 29-10-2013, and his Enlistment is valid upto 31-03-2026.

Whereas, the tender for the work C/O road from Dumi to Karyachi Km. 0/0 to 10/165 has been invited by the Superintending Engineer 4<sup>th</sup> circle HPPWD Shimla vide letter No. 13679-99 dated 21-12-2024 and the technical bids of the said tender has been opened on 8-1-2025 in which the 7 Nos bidder has been technically qualified. The Department has received representation/ objection from Sh. Lov Vij and Sh Satish Vij regarding work done submitted by Sh. Sanjeev Kapoor, Contractor.

Whereas the Superintending Engineer 4<sup>th</sup> Circle HPPWD Shimla conducted enquiry in to the allegation made by the complainers and found that Sh. Sanjeev Kapoor has tampered & changed the original form of document. The Superintending Engineer 4<sup>th</sup> Circle has recommended that the action against Sh. Sanjeev Kapoor under Enlistment Rule 2021.

Whereas show cause noticed has been issued by this office vide No. PW CTR/29/4<sup>th</sup> circle /Misc/2025-17860 dated 7-3-2025 and personal hearing was also conducted on 28-03-2025 in which, Sh. Sanjeev Kapoor also admitted the offence and intimated that the said documents has uploaded inadvertently as he was under stress due to passing of his mother. Sh. Sanjeev Kapoor has also given detail reply vide letter No 25-11-SK dated 18-03-2025.

Whereas the designated committee deliberated the case in detail and observed that the above Contractor has violated the Enlistment rule under rule 23.1 c & e by providing the fabricated information to acquire the work for C/O road from Dumi to Karechi Km. 0/00 to 10/165 in Distt., Shimla H.P. and above facts has also admitted by the contractor vide his letter dated 18-3-2025, Hence committee has found that the contractor has violated the Enlistment Rule 2021 by submitting the forge documents,

therefore, disciplinary action as per Enlistment Rule under Rule 23.1 may be taken against the above contractor.

Hence, in exercise of the powers delegated to the undersigned vide Govt., notification No. PBW(B)A (3) 1/2018 dated 13-4-2021 under rule 23.1,c & e, Sh. Sanjeev Kapoor S/O K.L. Kapoor R/O Kapoor Bhawan Totu Shimla Tehsil & Distt. Shimla H.P. Class "A" Contractor, enlisted vide this office order No. PW/-CTR-32-2 (2)/2012-39810—910 dated 29-10-2013 is hereby debarred from participating in the tender process for 3 month w.r f 1-4-2025 to 30-06-2025 of HP PWD, with immediate effect.
