Regarding admissibility of joining time and travelling allowance on transfer to the Contract Employees. . Madam/Sir,

In supersession of this department's letter No.PER(AP)-C-B(2)-2/2015, dated the 6th June, 2015 on the subject cited above, 1 am directed to say that the matter regarding revision of the admissibility of joining time and Travelling Allowance on transfer of contract employees was under consideration of the Government for some time past. The matter has been examined in consultation with the Finance Department and it has been decided to allow joining time and Travelling Allowance on transfer (except in cases where transfer is ordered on self request) to the contract employees, in the following manner:-

- (I) The joining time admissible tonly when the transfer has been made in public interest) will be:
  - i. One day in case the transfer to a station 30 km distance or less of the earlier station.
  - ii. Five days in case the transfer is to a station beyond 30 km. from the earlier station.
  - When holiday (s) follow(s) joining time, the normal joining iii. time will be deemed to have been extended to cover such holiday(s).

(II) The Travelling Allowance admissible will be as follows:-

- The actual expenditure incurred on the travel of self and the family members by any mode restricted to the fare of HRTC, for travel through the shortest route by ordinary buses.
- ii. However, the reimbursement of travelling expenditure will be admissible only in case the transfer is to a station beyond thirty kilometers and no reimbursement of travelling expenditure will be admissible in case the transfer is to a station within thirty kilometers from the earlier station.

2. These instructions may be brought to the notice of all concerned for strict compliance.
