Dear Mr. Gupta,

Skoch SMART Governance Index is the only time line based Index that has been measuring smartness of Indian states since 2003. The current cumulative national rank of Himachal Pradesh is #16.

Interactions with the state as well as anecdotal evidence tell us that the state may be doing far better than that. We feel that the reason for current rank could be fewer projects nominated for assessments for Skoch SMART Governance Awards compared to other states. We are keen to study your governance model and request a wider participation from the state to be able to accurately reflect its true position on the SMART Governance Index.

As you may be aware that our Index is the only such index based on primary research on projects offered by the state governments for evaluation. The index is used, as a reckoner by all stakeholders and is widely publicized.

We are now commencing this year's assessments through our Skoch SMART Governance Awards process and I would like to draw your personal attention to the fact that a higher number of well performing governance projects can be offered for evaluation across the good work being done by your government. This provides an opportunity for the state to get rated well and to improve its national ranking to be more reflective of the ground reality.

May I request that all your important departments working in any area where a difference has been made through a smarter governance, process or technology adoption should apply apply (few nomination forms enlosed). As always of particular interest to us are areas of IT, Infrastructure, Health, Education, Municipal Governance, Finance, Rural Development, and Power etc. This list is only indicative.

The last date for submissions for assessments is 24th July 2016 and the evaluations would be carried out in end July and early August. The awards and the rankings would be announced during the 45th Skoch Summit on Smart Governance to be held on 8-9th September 2016 at either Hyderabad or New Delhi.
