Subject: Splitting up of works.


Instructions issued vide this office letter No. PW/CTR/32-20/Genl. Instructions / 2012-1877-1976 dated 23-04-2012 have been reviewed and it is informed that Para 6.44 of Punjab PWD Manual of Order deals with the matter of splitting of works. The complete description of Para 6.44 of the said manual is re-produced as under:-

6.44 In exceptional cases where it is desirable to commence work on a project which has been administratively approved, before the detailed estimate for the whole project has been prepared, it is permissible for the authority competent to sanction the final technical estimates as a whole to accord sanction to detailed estimates for component parts of the project subject to the following conditions :-

- (i) For each such work or component part there must be fully prepared detailed estimate and in the administrative approval as a whole there must be a clear and specific amount corresponding to the work or component part in question.
- (ii) The amount of the detailed estimate must not exceed the amount included in the administrative approval by more than 5 percent
- (iii) The sanctioning authority must be satisfied, before according sanction that the amount of the technical sanction for the whole

project is not likely to exceed the amount of the administrative approval and that the work of component part in question can be appropriately commenced without affecting or being affected by any part of the project, financial or otherwise.

You are requested to take further action accordingly as per above mentioned provisions. However for PMGSY, World Bank & NABARD projects, the process of splitting, if essential, is governed by guidelines issued by the department from time to time.
