The Governor, Himachal Pradesh is pleased to implement the Mukhya Mantri State Health Care Scheme (MMSHCS) for the Ekal Naaris, Senior Citizens above 80 years of age, Anganwari Workers/Helpers and Mid-Day Meal Workers, Daily Wage Workers (State, utonomous Bodies, Societies, RKS, Boards & Corporations), Part-Time Workers (State, Autonomous Bodies, Societies, RKS, Boards & Corporations) and their families (up to the unit of five) irrespective of their income level, who are not covered under Rashtriya Swasthya Bima Yojna or any other Medical Reimbursement Scheme from the current financial year i.e. 2015-16. The scheme will provide cashless treatment in case of hospitalization in the empanelled hospitals to the tune of R 30,000/- under Basic Package and R 1,75,000/- under Critical Care through State

Nodal Agency i.e. HP Swasthya Bima Yojna Society.

The Contractual employees of State, Autonomous Bodies, Societies, RKS, Boards & Corporations and persons with more than 70% disability who are already covered, will be included in the scheme after completion of current round of policy period of RSBY. The beneficiaries will avail the benefit of scheme till 31st December, 2020. The new smart cards will be issued for next five years during the last year of scheme i.e. 2020. Following are the main

 - g. Suicide
 - All traditional medicines other than Ayurveda. h.
- (c) C overage of health services related to hospitalization and services of a surgical nature which can be provided on a daycare basis.
- (d) Cashless coverage of all health services in the package.
- (e) Provision for a smart-card based system of beneficiary identification /verification

(f) Provision for reasonable pre and post-hospitalization expenses for one day prior and 5 days after hospitalization, but subject to a maximum share of the total costs of the hospitalization in case of Basic Package of Rs. 30,000.

- (h) Provision for transport allowance (actual with limit of Rs. 100 per visit) but subject to an annual ceiling of Rs. 1000 under Basic Package.
- (i) Provision for transport allowance (actual with limit of Rs. 1000 per visit) hut subject to an annual ceiling of Rs. 3000 under Critical Care Package.
