Subject:- Transfer and posting of incumbents on Transfer & Promotion.

It has come to the notice of undersigned that despite of repeated instructions and letters issued by the Govt. as well as this office, recently issued vide letter No.5490-5590 dated 22.11.2024, the Controlling Officers are not adhering to the same and incumbents on transfers and promotions are not being relieved which is clear cut violation of Govt. orders. This act on the part of Controlling Officers has been viewed seriously. The instructions issued by the Govt. vide DoP letter No.Per(AP-B)E(3)-17/2012-Part dated 4<sup>th</sup> September, 2023 are hereby reiterated as under:-


*3.In view of above, it has been decided that the concerned Controlling Authorities be directed to relieve the officer/ officials promptly and not later than two working days in case of posts not requiring transfer of charge/inventory. In case of posts requiring transfer of charge/ inventory, the officers/ officials may be relieved not later than five working days. If a transferred employee is not relieved in this stipulated period, he will be deemed to have been relived. Failure to comply with these directions may invite disciplinary action under extant rules.*

It has further been observed that recently Sh.Anil Kumar, Jr.Tech.(W.I) on promotion as JE vide order dated 6.5.25 from Bilaspur Divn.No.I, Sh.Rajinder Singh, JE Civil vide order dated 23.5.25 from Jhandutta Divn., Sh.Pradeep Kumar Chandel, JE Civil vide order dated 23.5.25 from Sarkaghat Divn., Sh.Yogesh Kumar Viz, Junior Engineer(Civil) vide order dated 23.5.25 from Shimla Divn.No.III, Sh.Ramesh Kumar, Jr.Tech.(W.I) on promotion as JE vide order dated 2.6.25 from Ghumarwin Divn., Sh.Mahavir Singh, Jr.Tech.(W.I) on prom. As JE vide order dated 2.6.25 from Tanda Divn. & Sh.Rajinder Singh, Jr.Tech.(W.I) on prom. Vide order dated 2.6.25 from Padhar Divn. have been posted in MC Shimla. No intimation of their relieving / joining has been received in this office till

date. The said lapse for non-relieving of incumbents on promotion/ transfer is clear cut violation of rules / instruction on the part of controlling officer.


