The Managing Director, HPKVN vide his letter No. HPKVN1-1 DoTE/2016 -1325 dated 5-11-2016 has supplied preliminary estimates/drawings of CLCs / RLCs namely Sunder Nagar, Shamshi, Nahan and Pragati Nagar . Further vide letter No.HPKVN1-1 DoRD/2016 -1697 & 1698 dated 16-12-2016 has supplied case of RLC at Sadyana Mandi and RLC at Chopal. This office vide letter of even No.19840-46 dated 10-01-2017 has requested to the concerned Executive Engineers to attend this office along with their H.D.M. The Assistant Engineer Mandi-II, Assistant Engineer Sundernagar, draughtsman from Kullu Division attended this office on 2nd Feb.2017. The all original documents as received from HPKVN were handed over to these officers / officials. The documents of CLC/RLC at Chopal, Nahan and Pragatinagar has also been handed over to the concerned Executive Engineers. The A/A & E/S for RLC at Chopal amounting to Rs. 599.59 lacs, and for RLC at Sadyana amounting to Rs. 500.21 lacs has already been accorded by the concerned authorities.


It is therefore requested to send preliminary estimates for A/A & E/S directly to the concerned Department through Managing Director, HPKVN , SDA Complex Block No.24 Kasumpti Shimla -9 and also ensure to float tenders after completing all Codal formalities at the earliest as the HPKVN authorities are pressing for the same.
