

Ban on transfers-instructions thereof.

Sir,

I am directed to invite your attention to this Department's letter of even number dated 04-06-2014 on the subject cited above vide which a complete ban had been imposed on transfer and posting of employees. It has come to the notice of the Government that transfer proposals of the employees are still being entertained in violation of the instructions ibid for which the Government has taken a serious view being an administrative lapse.

2 It has been decided by the Government that henceforth no transfer or adjustments shall be ordered by any Department/Board/ Corporation and if any transfers are required to be ordered, the same will be ordered after obtaining the prior approval of Hon'ble Chief Minister through the concerned Minister in charge only in the following cases:

- i) To fill up the posts lying vacant in the Tribal & Difficult Areas.
- ii) Vacancies arising due to retirement, promotion and creation of new posts.
- iii) In cases where the employees are required to be transferred due to disciplinary/vigilance cases.
- iv) Due to exigencies of services.

3. These instructions may be brought to the notice of all concerned for strict compliance.
