Sir,

I am directed to invite your attention to this department's letter of even number dated 26-11-2015 on the subject noted above which inter alia provides that there will be no batch wise recruitment in any Class-I service in the State. The State Government has now decided that 50% recruitment on batch-wise basis in Class-I posts in Ayurveda, Dental and Animal Husbandry departments shall continue to be made as per provisions applicable prior to issuance of instructions dated 26-11-2015 and these instructions may be deemed modified to this extent.

2. It is, therefore, requested to ensure immediate implementation of the above decision and carry out suitable amendments in respective rules accordingly, after completing all codal formalities. These instructions may be brought to the notice of all concerned.
