Subject: - Filling up of vacant posts of Class-IV employees on compassionate grounds.


I am to say that prior to issue of Office Memorandum No. Fin-F(A)-(16)-1/2013 dated 24th January, 2022 from the Special Secretary (Finance) to the Government of Himachal Pradesh, Shimla (Copy available on the departmental website WWW.himachal.nic.in/finance under the link "Expenditure), this department was considering the applications for employment assistance to the post of Beldar on daily waged basis on compassionate grounds. Now, the Government vide aforementioned O.M., dated 24th January, 2022 has specifically and categorically clarified that direct quota un-advertised vacant posts of class-IV *excluding Beldar and other categories in the dying cadre*, in the Government Department(s) may be filled from amongst the eligible compassionate applicants.

The applications of the candidates/applicants, as per list, who have applied for the post of Class-IV Beldar on compassionate ground are pending with this office for scrutiny by the Departmental Screening Committee (DSC) and now their applications for the post of Beldar can not be placed before the DSC for consideration as the Government has decided not to fill up the post of Beldar on compassionate ground.

Now, therefore, the eligible applicants who have applied for the post of Beldar in HPPWD on compassionate ground can apply for the post of Class-IV, Peon/Chowkidar, if interested, and submit their consent/undertaking on the prescribed proforma to their respective Controlling Officer latest by 25th March, 2022. The Controlling Officer after countersignature will forward to this office directly in order to avoid delay in the matter. Any direct correspondence to this office by the applicant shall not be entertained.


Note:-The cases already decided shall not be considered/ accepted again.
