

Regarding admissibility of joining time and travelling allowance on transfer to the contract employees.

Sir,

I am directed to refer to subject cited above and to say that the matter regarding admissibility of joining time and travelling allowance on transfer to the contract employees was under consideration of the Government for some time past. The matter has been examined in consultation with Finance Department and it has been decided to allow joining time and travelling allowance on transfer (except in cases where transfer is ordered on self request) to the contract employees, in the following manner:-

(I) The Joining Time admissible (only when the transfer has been made in public interest) will be:

1. Three days in case the transfer is to a station within 150 kms. of the earlier station.
2. Four days in case the transfer is to a station beyond 150 kms. but within 200 kms. from the earlier station.
3. Six days in case transfer is to a place beyond 200 kms. from the earlier station.


(II) The Travelling Allowance admissible will be as follows:-

The actual expenditure incurred on the travel of self and the family members by any mode, restricted to the bus fare of HRTC, for travel through the shortest route by ordinary buses.
