The matter regarding delegation of powers for fixation of pay of the Class-I, II officers and III & IV officials in HPPWD are receiving attention of the Department for the last some time.

Whereas, the Vitta Sachiv, Himachal Pradesh Sarkar vide office Memorandum No. FIN©-A(3)-7/77 dated 18th February, 1977 has delegated powers for pay fixation which may be read as under :-

"Cases covered by the normal Rules:-Appointing authorities in the case of Class IV and III, and

Heads of Department in the case of Classes II & I shall be competent to issue formal sanctions in cases covered by the normal Rules, i.e. FR 22, FR 22-A, FR 22-B, FR 22-C, FR-30 and FR-31."

Whereas, in view of above delegation of powers to the Head of Department and in exercise of powers vested in me under Chapter-2, General System of Financial Management, Para- 12 of HPFR-2009, I hereby further delegate the powers for pay fixation of Class-I & II officers as well as Class-III & IV, having state cadre, to the respective Controlling Officers in HPPWD henceforth till further orders.

OFFICE MEMORANUM

The question of delegating administrative powers to Administrative Departments, etc., under the Fundamental Rules has been receiving attention of the State Government for sometime past. Accordingly, the Governor, Himachal Pradesh, is pleased to delegate powers to various authorities, with immediate effect, as under:-

 F.R. 9(6) (b)(i) Treating Wh Govt. servants as on exc duty while under training.

When the training does not exceed six months.

Heads of Department shall be competent to issue sanctions, subject to fulfillment of the following conditions:-

- (i) The training/instruction should be in India,
- (ii) The training/instruction should be connected with the post which the Govt. servant is holding at the time of placing him on training/instruction,
- (iii) It is obligatory on the part of Govt. to send the person for such training/instruction.

and

- (iv) The training should not be in professional or technical subjects which are normally brought under the provisions relating to study leave.
- (b) When the training Adm exceeds six months con but does not com exceed one year. sub

Administrative Department concerned of the Govt. shall be competent to accord sanction, subject to the fulfillment of the conditions laid down above.

(2) F.R. 27- Grant of advance increment under the Family Planning Programme. Appointing authority of the employee who undergoes, vasectomy/tubectomy operation after a maximum of two living children in accordance with the pattern laid down by the Govt. in the Health and Family Planning Department. (3) Acceptance of FEE by officers/officials of the Revenue Department for Demarcation work, etc.

(4) Pay-fixation.

The Divisional Commissioner shall be competent to accord sanction.

Cases covered by the normal Rules:-Appointing authorities in the case of Class IV and III, and

Heads of Department in the case of Classes II & I shall be competent to issue formal sanctions in cases covered by the normal Rules, i.e. FR 22, FR 22-A, FR 22-B, FR 22-C, FR-30 and FR-31.

2. While issuing sanctions, authorities to whom powers as above are delegated shall ensure that copies of the orders so issued are always endorsed to the Finance Department (Regular Section) in the interest of proper verification/check.
