OFFICE MEMORANDUM

Subject:- Appointment of sons/daughters/near relations of Government servant who die in harness leaving his family in immediate need of assistance - Modification thereof.

1. As per Notification No. GAD(CC)-5-2/71 dated 04.09.2013, the subject matter regarding "All policy matters relating to formulation/amendment in the existing policy of providing employment assistance to the dependents of the deceased Government servants including issue of instructions as and when required and providing of employment assistance to the eligible dependents thereunder" has been allotted to FINANCE DEPARTMENT vide Serial No. 29 of the Business of the Government of Himachal Pradesh (Allocation) (144th Amendment) Rules, 2013.

2. Vide Department of Personnel's OFFICE ORDER No. Per.(AP-II)-F-(4)-4/89 dated 25.04.1991, power(s) to accord relaxation in age, educational qualification and time limit(s) for submission of compassionate employment case(s) were delegated to the respective Administrative Secretaries in case of Class-IV category while same were vested with the Hon'ble Chief Minister in case of other cases except Class-IV category.

3. In order to gear-up the efficiency in administration, after careful consideration, the provision(s) of Para(s): 7(c) & (d) & Para:8 of the Department of Personnel's Office Order ibid are henceforth further substituted as under:-

In case(s) of Category	Relaxation in educational qualification(s) and time limit(s) for submission of compassionate employment cases to be accorded by concerned Administrative Departments will also be Government service in appropriate compassionate employment.
In case(s) of all other(s) except Class-IV Category	Relaxation in time limit for submission of compassionate employment cases is to be accorded by Chief Minister. No relaxation in educational qualification(s) in case of Category-III is permissible in terms of DOP's O.M. dated 14.08.2008. The Administrative Departments will also be competent to accord relaxation in age for joining Government service in appropriate cases of compassionate employment.

4. The above amendment may be brought to the notice of all concerned for information and strict compliance.

5. These instructions will come into force with immediate effect.
