In this regard, it is again re-iterated that if a retiree intends to retain his GPF accumulations with the State Government beyond the prescribed period of six months she/ he may be allowed to do so with the permission of the Head of office on receipt of written request from him to this effect as per instructions issued by the Finance Department vide notification dated 28th August, 2007 and letter No.Fin(C)A(3)5/2002 dated 18th December, 2012. In case, a retiree applies to retain his GPF accumulation with the Govt. directly to the A.G. Office without permission of the Head of Office, in that eventuality, no interest on GPF accumulation will be given to the retiree.
