I am directed to invite your attention to this department's letter of even number dated 25th February, 2019 on the above noted subject and to clarify that the benefit of counting past service rendered in the armed forces towards pay fixation may be given strictly in accordance with the provisions prescribed under rule 5(1) of the Demobilized Armed Forces Personnel (Reservation of Vacancies in the Himachal State Non-technical Services) Rules, 1972 as well as the Ex-servicemen (Reservation of vacancies in Himachal Pradesh Technical Services) Rules, 1985 as amended from time to time, which stipulates that the period of approved military service rendered after attaining the minimum age and qualification prescribed for appointment to the service concerned, by the candidate(s) appointed against reserved vacancy under the relevant rules, shall count towards fixation of pay in that service at the time of first civil appointment against reserved vacancy.
