

**NOTIFICATION**

In continuation of this department notification of even number dated 27<sup>th</sup> May, 2021, Para-2 of the guidelines for publicity of tenders in HPPWD is hereby revised as under:

**Para-2.** (i). The tender notice in respect of works costing up to Rs. 1.00 Lakh would not require publication in Newspaper and shall be displayed on notice board of SE's, EE's and Asstt. Engineers of HP PWD concerned. A certificate will be issued by the office of the Superintending Engineers about the date of display of notice in his office and period of notice shall be counted from that date. Notice period will be 7(Seven) days. In addition to this, copies of such tender notice shall also be displayed for one week(7days) in the offices of Panchayat Samiti, Municipal Bodies, Sub-Divisional Officer(Civil) and Deputy Commissioner. The copies of such notices shall also be sent to those Contractors who are working in a particular Sub-Division or whose registered office is in that Sub-Division.

(ii). The tender notice of works costing above Rs. 1.00 Lakh to Rs. 5.00 Lakh shall be processed without press notice. There shall be overall ceiling of Rs. 25.00 Lakh per Division per annum subject to the following:

1. A certificate of exigencies/emergency would be given by the Executive Engineers.
2. When sufficient reasons exist which indicate that it is in public interest.
3. Tenders will be uploaded on department website and notice board of the Division and Sub-Division alongwith schedule of quantity.
4. NIT register will be maintained and will be available for contractors for perusal during a fixed time on working days of tenders not invited through e-tendering.

The other guidelines issued ibid will remain unchanged.
