Regarding informing result of selections to concerned Employment Exchanges in H.P.

Sir,

It has been observed by the Hon'ble Minister Labour & Employment to the Government of Himachal Pradesh during the review meeting of Department held at Bathu (Haroli) District Una on 02.07.2016 that up to date statistics of placements/recruitments made by the Government in different departments are not being reflected in the statistical returns of Department. As you are well aware that all the Government Departments/Corporations/Boards/Urban Local Bodies and Companies under the Government are bound to inform the result of selections/recruitments made by them to the concerned Employment Exchange under the Provisions of Employment Exchanges (Compulsory Notification of Vacancies) Act, 1959 and Rules, 1960 framed thereunder. This enables the Department to

consolidate the statistics of recruitments made by the Government which, resultantly facilitate the Government in formulation of better policy to minimize the unemployment problem in the State as well as in the country.

It has been observed that large number of recruitments have been made by the Government during last three years in various departments, but result of selections in large number of cases have not been sent to the concerned Employment Exchanges in the State. Resultantly, the Department is unable to compile the correct/up to date figures of placements and the recruitments of job seekers registered with Employment Exchanges are not reflected in our Live Register. Government of Himachal Pradesh is taking serious view of this and pressing hard to take appropriate action in this regard.

You are, therefore, requested to inform the result of recruitments made by your department w.e.f. 01.01.2013 to 30.06.2016 to the Employment Exchange in which the recruited person is/was registered, so that necessary entry in this regard is made in the Live Register of concerned Employment Exchange and ensure that result of all selections may invariably be intimated to concerned Employment Exchange in Future also.

You are further requested to also give directions to your field officers to comply with the provisions of the Employment Exchanges (Compulsory Notification of Vacancies) Act, 1959 to avoid prosecution and save embarrassment to the Government.
