

In reference to the above subject cited matter, It is informed that after implementation of GST in Public Works Deptt. vide Govt. decision dated 07.08.2019 all Contractors are free to buy all type of material from Open Market except Cement, which is supplied by the H.P. Civil Supply Corp. on Rate Contract and HPSIDC has requested to make necessary amendment in the Govt. decision so that Bitumen (all grade of hot mix/emulsions) and Steel including TMT bars be purchased by the Contractor through HPSIDC Depots within the State to ensure quality, quantity and timely delivery of the materials and may not suffer loss being a Govt. owned Corporation.
