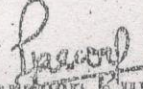

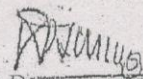
The Government of Himachal Pradesh Finance (Budget) Department (copy enclosed) has opened a Sub Minor Head 17-eProcurement of Tender Fee under Major Head 0070-Other Administrative Services for collecting eProcurement Tender Fee. As the ICICI bank is authorized for collection of Tender and EMD on eProcurement by DIT therefore, ICICI bank will generate challan on eChallan portal on daily basis and remit the tender money to the state government on above mentioned sub Minor head.

Therefore all DDOs under your control may be directed to:-

1. To collect the fee (Tender Fee+EMD) through online mode only. —
2. Collected fee will be deposited against the DDO of tender floating the tender. —
3. Department may provide DDO (preferably at HQ level) to ICICI bank to remit the tender money collected through online mode. —
4. Tender fee collected will be remitted by ICICI bank on T+1 basis against one DDO designated by the department, —
5. DDO at HQ level can reconcile the receipt by comparing e-procurement MIS with eKosh. —

Further, ICICI bank will provide MIS report of the receipt deposited by departments to the DDO and to this office on daily basis.
