## PMGSY works SQM and NQM Grading 2019-20

During 2019-20, Out of 992 inspections done by State Quality Monitors 806 works are Satisfactory, 132 are Satisfactory but Require Improvement and 54 are Unsatisfactory.

During 2019-20, Out of 299 inspections done by National Quality Monitors 239 works are Satisfactory, 29 are Satisfactory but Require Improvement and 31 are Unsatisfactory.

The Grade improvement to Satisfactory level still require 132 SRI and 54 Unsatisfactory works as per SQM inspections and 29 SRI and 31 Unsatisfactory works as per NQM inspections rectification.

ATRs are to be verified by SQMs in coming months and all out efforts are to be made to make all roads Satisfactory by December,2020. Special attention is required in Kangra, Kullu, Shimla, Mandi and Bilaspur Districts where Unsatisfactory works are to be rectified and inspected on priority

### PMGSY works SQM and NQM Grading 2020-21

During 2020-21, Out of 370 inspections done by State Quality Monitors 314 works are Satisfactory, 41 are Satisfactory but Require Improvement and 15 are Unsatisfactory.

During 2020-21, no inspections have been done by National Quality Monitors in view of Covid-19 movement restrictions.

The Grade improvement to Satisfactory level still require 41 SRI and 15 Unsatisfactory works as per SQM inspections rectification.

ATRs are to be verified by SQMs in coming months and all out efforts are to be made to make all roads Satisfactory by September,2020. Special attention is

required in Mandi District where Unsatisfactory works are to be rectified and inspected on priority.

#### PMGSY works SQM Inspection Target for 2020-21

Against 1127 inpection target for SQMs for 2020-21, 322 inspections have been conducted. All out efforts are being made to achieve the target by end of March, 2021.

There are still 200 works not Inspected by SQM even once. It was assured by all CEs and SEs that needful will be done in coming 2-3 months to get all on going works inspected by SQMs.

# Pradhan Mantri Gram Sadak Yojana Packagewise Lab Established Report

There are still 165 pacakges where laboratory has not been established. Out of 165, in 91 works more than 6 months have lapsed. It was assured by all CEs and SEs that needful will be done in coming 2-3 months
