BROAD GUIDLINES ON HIMACHAL ROAD IMPROVEMENT SCHEME

(HRIS) 2018

1. Introduction:-

- 1.1.1 Rural road connectivity is not only a key component of rural development in the state, but also recognized as lifeline of state and an effective poverty reduction programme. About 75 % of habitations in the state are so far connected by motorable roads. Total length of the roads is about 35,638 Km. Out of which, 25,454 Km. are metalled and 10,184 Km. are unmatlled with 29, 812 Km cross drainage works.
- 1.2 It is also observed that due to some missing cross drainage and side drains, some roads can't be said to be all weather roads. Therefore, Himachal Pradesh Government decided to introduce a new scheme for filling up this gap and integrate the drainage system in an effective way, besides mitigating with damage problem to the surface of the road due to surface water.

2. Progarmme objective & coverage

2.1 Government of Himachal Pradesh has resolved to provide all weather road connectivity to all the habitations in Himachal Pradesh and rolled out a new scheme during March 2018 along with allocation of Rs. 50 Crore for financial year 2018-19 for construction of missing CD's and side drains on all state roads. This scheme has been named as "Himachal Road improvement Scheme (HRIS)"

3. Implementation and Monitoring of Programme.

- 3.1 H.P.P.W.D. shall be the executing agency under this scheme. Every division shall be P.I.U. for planning, construction and disbursement as per necessity / priority at site. Each Division shall identify such missing C.D's/ side drains and prepare inventory of every road under their jurisdiction.
- 3.2 Funds shall be released by H.O.D. to every divisions/PIU in a phased manner as per the requirement.
- 3.3 Executive Engineer shall maintain a separate record of construction done under this scheme. He shall submit quarterly physical & financial progress to higher authorities for monitoring at Circle/Zonal/Head office level.
- 3.4 The work shall be executed as per HPPWD/MORD specifications. The payment to the contractor shall be released by Executive Engineer only after formal inspection by concerned Superinténding Engineer. The sanctioned works under this scheme shall be completed within the same financial year.
- 3.5 The department may issue directions time to time as may be necessary for smooth implementation of this scheme.
