Subject: - Review DPC convened w.e.f 14-6-1984 on wards for the promotion to the post of Assistant Engineer (Civil)(Implementation of Hon'ble High Court orders dated 08-01-2010 CWP (T) No1358/2008, 2605/2008, 2275/2008 and dated 03-03-2011 in COPC No214/2010.

Sir,

I am directed to say that in compliance to the orders of Hon'ble High Court in above mentioned CWP (T)/COPC, review DPCs were convened for consideration of eligible Graduate/AMIE passed out Junior Engineers (Civil) to the post of Assistant Engineer (Civil) where after an integrated tentative seniority list of all Assistant Engineer (Civil) showing position as on 31-3-2012 was issued /circulated on 6-4-2012 by the Govt to all concerned and further vide this office letter No PWE-141-16-ES-II/-173-85 dated 16-4-2012.

In response to above mentioned tentative seniority list a number of objections/representations were sent to Govt by individuals. After careful consideration /examination of these representations, it has been decided by the Govt. to convene a further review DPC right from 14-6-1984, after obtaining the options for promotion from all those officials who have improved their qualification after joining as Junior Engineer.


In this regard the necessary Performa at the website of the HPPWD has been uploaded and can be downloaded from www/hppwd.gov.in/download.htm, so that all AMIE passed out Junior Engineers (Civil) could submit their option for promotion to the post of Assistant Engineer (civil) as per their own preference. The option should reach to Govt before 25-7-2012 and option received after 25-7-2012 may

summarily be rejected. Further, it will be presumed that the concerned officer(s) is to be considered for promotion to the post of Assistant Engineer (Civil) from "AMIE passed put Junior Engineer (Civil)" stream exclusively.

It is therefore requested to issue necessary directions/instructions to all Superintending Engineers, Executive Engineers, Assistant Engineers and Junior Engineers working under your control so that the supply of above mentioned option form to all concerned could be ensured so that they may submit duly filled up option form within stipulated time period enabling the Govt. to process further in the matter.
