With reference to your office letter referred above and the power point presentation given on dated 17-08-2019 along with the documents supplied on the day of presentation and subsequently, the committee is of the view that the following products i.e. SSL, MS and RSI which were tested/certified by CRRI, IIT Delhi and BIS, is recommended to be used in HPPWD with the following conditions.

- a) The raw material used for the production of emulsion should be procured from PSU's (Indian Oil Corporation and Hindustan Petroleum)
- b) Each lot of material supplied must be accompanied with manufactures test certificates from NABL accredited labs.
- c) The lot wise Independent Quality Control tests shall be conducted on each supply lot.
- d) The material supplied should fulfill all the norms as per specifications of IRC/MORTH guidelines as per IS code 8887-2018 in toto.
- e) This recommendation is valid for one year initially and can be renewed further on the basis of performance of these products issued by the concerned Chief Engineers if applied by the firm.
