## **NOTIFICATION**

The Governor, Himachal Pradesh, in pursuance to the Additional Chief Secretary (Personnel) to the Government of Himachal Pradesh letter No.Per(AP)C-B(2)-2/2015 dated  $11^{th}$  May, 2018, is pleased to regularize the services of the following Contract Assistant Engineers (Civil), HPPWD in the pay scale of Rs.15600-39100 + Rs.5400 Grade pay who have completed 03 years of continuous service as on 30.9.2018 with immediate effect in the public interest:-

The terms and conditions of regularization of the above officers are as under:-

- (i) The post of Assistant Engineer (Civil)(Gazetted, Class-I), is temporary but is likely to continue.
- (ii) That on regularization, the officers shall be appointed on the minimum of the time scale and fixation of pay will be done under the provisions of normal rules and orders/instructions in force & issued from time to time.
- (iii) The officers will be on probation for a period of 02 years from the date of joining the post. The period of probation is liable to be extended at the discretion of the Appointing Authority. Failure to complete the period of probation to the satisfaction of the Competent Authority will render them liable to be discharge from service.
- (iv) The officers shall have to pass the prescribed departmental examination within the probationary period, failing which they shall not be eligible for:-
  - (a) The grant of higher pay scales etc.
  - (b) Confirmation to the service; and

(c) Promotion to the next higher post.

(v) The appointment may be terminated at any time by one months notice given either side viz. the appointee or the appointing authority. The appointing authority, however, reserves the right of terminating the services of the appointee forthwith or before the expiry of the stipulated period by making payment of a sum equivalent to the pay and allowances for the period of notice or the un-expired period thereof.

- (vi) The officer will be liable to serve in any part of Himachal Pradesh.
- (vii) The regularization shall be subject to the verification of character and antecedents, as provided by the HP Financial Rules.
- (viii) The regularization of the officers shall be subject to the production of Medical Certificate of fitness from the Chief Medical Officer, DDU, Hospital, Shimla.
- (ix) The Officers will be required to take an oath of allegiance/ faithfulness to the Constitution of India (or make the solemn affirmation to that effect) in the prescribed form.
- (x) The Officer will be required to submit declaration in the prescribed form that in case you are married, you have only one living wife. In the event having more than one wife living, the appointment will be subject to being exempted from the enforcement of the requirement in this behalf.
- (xi) Other conditions of service will be governed by the relevant rules and orders issued by the State Govt. from time to time.
- (xii) If any declaration given or information furnished by the officers proves to be false or if found to have willfully suppressed any material, information, will be liable for removal from service and such other action as may be deemed necessary.
- (xiii) The officers are required to produce all original certificates in support of their qualification/technical education, age and belonging to any reserved Class against which they are supposed to be appointed at the time of joining the post.

The above officers are directed to join their duties within 07 days and submit charge assumption report to this department, immediately. It is also stipulated that they can be shifted to other suitable places of posting as per Contd.Page-3 requirement after 3-4 months in relaxation to transfer policy.
