In pursuant to approval conveyed by Additional Chief Secretary (PW) to the Govt. of HP. These appointments have been ordered subject to the following terms and conditions:-

1. The contract appointee will be paid fixed contractual amount @ Rs:- 5910+1900GP + Addl. 100% GP Rs:- 1900 PM.(which shall be equal to minimum of the pay band + Grade Pay). The contract appointee will be entitled for increase in contractual amount @ Rs:- 234/- (3% of minimum of the pay band grade pay of the post) alongwith Rs:- 25/- Basta Allowance, Rs:- 25/- Stationary Allowance, Rs:- 150/- FTA (if posting is in Patwar Circle) Rs:- 50/- Electricity Allowance (if posting is in Patwar Circle) for further extended years and no other allied benefits such as senior/selection scale etc. Will be given.
2. The service of the contract appointee will be purely on temporary basis. The appointment is liable to be terminated in case the performance/contract of the contract appointee is not found satisfactory.
3. Contract appointee, will be entitled for one day casual leave after putting one month service, 5 days special leave and 10 days leave on medical grounds are allowed in a calander year. Besides no leave of any other kind is admissible to the contract appointee. He/She shall not be entitled for medical re-inbursement and LTC etc. Maternity leave will also be given to female employees as per rules.
4. Unauthorized absence from the Govt. duty without any approval of the controlling officer shall automatically lead to the termination of the contract. Contract appointee shall not be entitled for contractual amount for the period of absence form duty.
5. An official appointed on contract basis who have completed three years tenure at one place of posting will be eligible for transfer on need basis, wherever required on administrative grounds.
6. The Contract appointee will have to submit a certificate of his/her fitness from a Govt./Regd. Medical Practitioner. Women candidate pregnant beyond 12 weeks will stand temporarily unfit till the confinement is over. The women candidate will be re-examined on the fitness from an authorized Medical Officer/Practitioner.
7. The Contract appointee will be entitled to TA/DA if required to go on tour in connection with his/her official duties at the same rate as applicable to regular counter part official at the minimum of pay scale.
8. Provisions of service rules like FR SR, leave Rules, GPF Rules, Pension Rules & Conduct Rules etc. Will not be applicable in case of contract appointees. He /She will be entitled for emoluments etc. As detailed in first column above.
9. In case the above offer is acceptable to above candidate he/she has to execute a contract deed/agreement with the undersigned after producing all relevant certificates before joining the duty within 10 days from the receipt of this order positively failing which the offer will automatically stand cancelled.
10. The contract can be terminated at any time before expiry of one year period after giving a notice of 30 days or advance payment of one month period emoluments/contractual amount without assigning any reason. If the candidate wants to quit the contractual service, he/she will require to give one month notice in advance or deposit one month contractual amount.
11. The contract is further subject to good moral conduct and efficiently discharge of the duties during the currency of contract and the candidate will submit the



agreement for renewal before expiry of one year alongwith work and conduct certificate from concerned LAO /Naib Tehsildar under rules till he is not regularized.

12. Any other condition on the appointment on contract basis regarding service as laid down by the Govt. from time to time will be applicable on all the candidates.
13. No TA will be paid for joining the post.
14. If any declaration or information furnished by him/her proves to be false or wilfully suppressed any material/information, he/she will be liable for removal from the contractual service or such action as deemed fit will be taken under rules.
15. He/She will require to take oath/affirm on the following form:-
