

The above regularization are subject to the following conditions;-

- 1. They are entitled for the pay scale of Rs. 5910-20200 plus Rs. 1900/- Grade pay, and fixation of pay will be done under the provision of normal rules. They shall be entitled for other allowances whatsoever are admissible to the employees of State Government from time to time.
- 2. Their age at the time of joining the post should neither be less than 18 years nor more than 45 years. It is relaxable by five years in the case of Schedule Caste/Schedule Tribe classes.
- 3. The regularization shall be subject to verification of character and antecedents, as provided by the HP financial Rules.
- 4. Their appointment shall be subject to the production of Medical Certificate of fitness from the Distt, Medical Officer of the Govt. Hospital.
- 5. They are liable to serve in any part / Area where HP PWD has its organization.
- 6. They are required to produce antecedent verification certificate to the satisfaction of the department from the First Class magistrate or two Gazetted officers known to them at least for last five years.
- 7. They are also required to produce all original certificates in support of their qualification/technical education, age, Himachali bonafide and belonging to any reserved Class against which they are proposed to be appointed at the time of joining the post.
- 8. Their services can be terminated prematurely without assigning any reason on one month notice or with one month wages.



10. They will have to pass type test as prescribed in the R&P Rules. 11. They will require to take oath /affirm on the following form;do swear /solemnly affirm that I will be faithful and either bear true allegiance to the constitution of India as by laws established and that I shall carry out the duties of my office with loyalty, honestly and impartiality \* So help me God. \* If they accepts the offer on the terms and conditions given above ,They should report for duty to controlling officer of the as mentioned in Column No-4 above, within a period of 15 days, failing which the offer shall be cancelled automatically.
