In pursuance of Additional Chief Secretary (Personnel) to the Government of Himachal Pradesh letter No. PER(AP)C-B(2)-2/2015-L dated 4.5.2017 and on the recommendations of Departmental Screening Committee, the services of following Junior Engineers(Mechanical)contract basis who have completed three years of continuous service as on 31.3.2017 are hereby regularized in the pay scale of Rs. 10300-34800+3800 Grade pay(initial start Rs.14590) and further posted as mentioned against each.:-

The above regularization are subject to the following conditions:-

1. They are entitled for the pay scale of Rs. 10300-34800 plus Rs. 3800/- Grade pay(initial start Rs.14590/-) , and fixation of pay will be done under the provision of normal rules. They shall be entitled for other allowances whatsoever are admissible to the employees of State Government from time to time.
2. Their age at the time of joining the post should neither be less than 18 years not more than 45 years. It is relaxable by five years in the case of Schedule Caste/Schedule Tribe classes. Provided that the upper age limit for direct recruitment will not be applicable to the candidates already in service of the Govt. i/c those who have been appointed on adhoc or on contract basis.
3. In case any one wishes to resign he will give at least one month notice to enable the department to make arrangements for his substitute.. The discretion to accept or to reject his resignation will rest with the appointing authority but in no case he shall be



relieved from his charge until and unless the resignation is finally accepted by the competent authority. In case of any failure of part of official on this account he will be liable for disciplinary action and will permanently debarred from Govt service in future.


4. The regularization shall be subject to verification of character and antecedents, as provided by the HP financial Rules.
5. Their appointment shall be subject to the production of Medical Certificate of fitness from the District/ Medical Officer of the Govt. Hospital.
6. They are liable to serve in any part / Area where HP PWD has its organization.
7. They are required to produce antecedent verification certificate to the satisfaction of the department from the First Class magistrate or two Gazetted officers known to them at least for last five years.
8. They are also required to produce all original certificates in support of their qualification/technical education, age, being a Citizen of India/Himachali bonafide and belonging to any reserved Class against which they are proposed to be appointed at the time of joining the post.
9. Their services can be terminated prematurely without assigning any reason on one month notice or with one month wages.
10. They shall have to submit assets & liability statement.
11. They should give declaration that they have not more than one living wife.
12. They will be governed by the CCS & CCA conduct Rules.
13. The regularization will be with prospective effect i.e. from the date of issue of regularization orders.
14. They will require to take oath /affirm on the following form;-

I \_\_\_\_\_ do swear /solemnly affirm that I will be faithful and either bear true allegiance to the constitution of India as by laws established and that I shall carry out the duties of my office with loyalty, honestly and impartiality

If they accepts the offer on the terms and conditions given above ,They should report for duty to controlling officer of the as mentioned in Column No-4 above, within a period of 15 days, failing which the offer shall be cancelled automatically.
