The above regularisation is subject to the following conditions:-

- 1. They are entitled for the pay scale of Rs. 10300-34800 plus Rs. 3800/- Grade pay (initial start Rs. 14590) and fixation of pay will be done under the provision of normal rules. They shall be entitled for other allowances whatsoever are admissible to the employees of State Government from time to time.
- 2. Their age should neither be less than 18 years not more than 45 years. Provided that the upper age limit for direct recrumetment will not be applicable to the candidares already in service of the Govt. i/c those who have been appointed on adhoc or on contract basis.
- 3.In case any one wiches to resign he will give at least one month notice to enable the department to make arrangements for his substitute. The discretion to accept or to reject his resignation will rest with appointing authority but in no case he shall be relieved from his charge until and unless the resignation is finally accepted by the competent authority. In case of any failure or part of official on this account he will be liable for disciplinary action and will permanently debarred fron Govt. service in future.
- 4. The regularisation shall be subject to verification of character and antecedents, as provided by the H.P. financial Rules.

- 5. Their appointment shall be subject to the production of Medical Certificate of fitness from the District /Medical Oficer of the Govt Hospital.
- 6. They are liable to service in any part / Area where HP. PWD has its orgainsation.
- 7. They are required to produce antecedent verification certificate to the satisfaction of the department from the First Class Magistrate or two Gazetted officers known to them at least for five years.
- 8. They are required to produce all original certificates in support of their qualification /technical education, age, Citizen of india/Himachaal Pradesh Bonafide and belonging to any reserved class against which they are propsed to be appointed at the time of joining the post.
- 9. Their services can be terminated prematurely without assigning any reason on one month notice or with one month wages.
- 10. They shall have to submit assets & liability statement.
- 11. They should give a declaration that they have not more than one living wife.
- 12. They will be governed by the CCS &CCA conduct Rules.
- 13. The regularisatin will be with prospective effect i.e. from the date of issue of regularisatin orders
- 14. They will required to take oath/affirm on the following form.

I ______do swear/solemnly affirm that I will be faithful and either bear true allegiance to the constitution of India as by laws established and that I shall carry out the duties of my office with loyalty, honestly and impartiality.

If they accepts the offer on the terms and conditions given above, they should report for duty to controlling officer of the as mentioned in Column No4 above, within a period of 15 days, failing which the offier shall be cancelled automatically.
