- 1. The appointment shall be on contract basis initially for a period of one year from the date of joining the post, but contract can be renewed thereafter on yearly basis which will stand terminated automatically at the end of contractual period without notice.
- 2. He/She will be paid fixed consolidated monthly emoluments equivalent to the minimum of the pay band of 5910-20200 + 1950 Gr. Pay + 75 % of Grade Pay. He/She shall not be entitled for any other allowance whatsoever is admissible to the employees of State Government from time to time.

- 13. Transfer of the contract appointee shall be permitted after the completion of 3 years.
- 14. He/She will be entitled to TA/DA if required to go on tour in connection with his/her official duties at the same rate as applicable to regular appointee.
- 15. The employees group insurance scheme, EPF and GPF will not be applicable to him/her.
- 16.
