ORDER

Whereas, Sh.Ravinder Kumar, Assistant Engineer (D) o/o Chief Engineer (HZ), HPPWD, Hamirpur had filed OA No.3365/2018 in the Hon'ble HP Administrative Tribunal and had sought relief that respondent may be directed to transfer him out of Hamirpur i.e. from the present place of posting to the station of choice i.e. (i) AE to EE. Una or (ii) AE to EE Kangra against vacancy or longer stay.

That the said OA was finally disposed of by the Hon'ble Tribunal on 15.6.2018 with the following direction:-

PARA-6:-In view of the ground stated for rejection of the representation of the applicant, no further indulgence by this Tribunal is warranted in the matter. However, as prayed for, the applicant may take up the matter with the competent authority with a request for transfer against an existing vacancy either in HPPWD Division, Una or HPPWD Division, Kangra by way of representation, which may be filed within ' a week from today and the same shall be considered and decided by the said authority in accordance with law and the transfer policy framed by the State Govt., within a further fortnight, after affording an opportunity of being heard to the applicant.

That, as per direction passed by the Ld. Tribunal on 15.6.2018, the applicant had made a representation on 20.6.2018, in which he has submitted that feeling aggrieved against his transfer order from EO, HPPWD, Circle Hamirpur to the o/o CE (HZ), HPPWD Hamirpur as AE (D), he had filed OA No.1596/18. As per direction passed by the Ld. Tribunal, he had made representation which was decided by ACS (PW) and unfortunately his representation was rejected with the remarks that he has some personal interest to remain as EO, HPPWD Circle, Hamirpur. He felt very bad after reading the remarks in order, without taken into account his entire service career. Therefore, he again approached the Hon'ble Tribunal vide OA No.3365/18 in which he had prayed that if this is the impression went to his senior official for making representation, they may be asked to transfer him out of district Hamirpur either in the office of AE to EE at Una or Kangra District. The Hon'ble Tribunal passed an order to make representation before ACS (PW) for relief, hence, he prayed that his transfer order may be passed keeping in view of his superannuation and he does want

that any stigma may be put on him as only 02 months are left for his service. He stated that during his entire service career there has been no complaint against him, as he always obeyed the order of his superior. In the end, said officer requested that either his transfer order may be quashed or he may be transferred out of Distt. Hamirpur to the vacant post of AE to EE in District Una or Kangra keeping in view of his superannuation.

That after receipt of representation, the applicant was given personal hearing on 29.9.2018 at 3.00 PM. During the course of personal hearing, the applicant stated that since he has already joined as AE (D) o/o Chief Engineer (HZ), HPPWD, Hamirpur and now he has left 02 months for retirement, therefore, he does not want to pursue his case and he may kindly be allowed to continue at the present place of posting.

Now therefore, keeping in view of the submissions made by the applicant during the course of the hearing, the representation made by the applicant has been considered and he has been directed to continue as AE (D) o/o CE (HZ), HPPWD. Hamirpur.
