withdrawn without notice and opportunity to next official in the line shall be promoted

If any of the promote proceed on leave to avoid his joining in his new place of posting within stipulated period, disciplinary action will be initiated against the defaulter.

If an official forgoes his promotion then he will be considered for promotion after one year or whenever the post is available, whichever is later.


In the case, any error in the present place of posting of promotes occurs/or any other type of error/lapse regarding promotion, the same may be got rectified in consultation with this office or these order can be withdrawn any time without given any notices.
