**OFFICE ORDER**

On the recommendation of Departmental Promotional Committee, the following Senior Scale Stenographer presently working in the pay scale of Rs.10300-34800+4400 Grade pay are hereby promoted to the post of Personal Assistant in the pay scale of Rs.10300-34800+4800 Grade pay on regular basis with immediate effect in the public interest.

In case the above officials desired to fix their pay under FR 22 read with rule 11 of the Himachal Pradesh Civil Services Pay (revised) rules, 2009, they are required to exercise their option within one month from their promotion in the pay scale of Rs. 10300-34800+4800 grade pay.


Consequent upon their promotion to the post of Personal Assistant in the pay scale of Rs. 10300-34800+4800 grade pay, the posting orders are hereby ordered as under with immediate effect in the public interest:-

The officials posted outside the radius of 25 KM are entitled for TTA/ joining time.

Before the above orders are implemented, the concerned Head of the office will ensure that the promotees fulfill the appended conditions:-

1. The above promotees will join at the place of his/her posting on promotion within 15 days from the date of issuance of this order failing which the promotion orders shall be deemed to be withdrawn automatically for one year or till the date of next D.P.C. whichever is later. No specific orders with reference to withdrawal of promotion will be issued separately.
2. No promotee has right to forgo the promotion in public interest and promotion can be enforced. However, if someone applies to adduce for refusal of promotion to the appointing authority, he/she will be debarred for one year or up to the next DPC whichever is later. In case of non acceptance of reason to forgo the promotion by the accepting/ appointing authority, he/she will not be considered for promotion in future and shall be debarred forever.
3. The above promotion is subject to review due to any consequential administrative reasons.
4. Those who have been posted outside the sub-cadre/ Tribal area will have to serve in difficult sub-cadre as and when it is administratively required.
5. That in case of any factual error/ omission is detected later on, the promotion orders so issued will be withdrawn and the concerned official shall have no claim for the same. The Controlling Officer will obtain an undertaking to this effect from every promotee before they are relieved on promotion to the next station.
6. **Before relieving the official to join the new place of posting on promotion it may be ensured that no fresh departmental inquiry/vigilance case is pending against the said official, if so same may be brought to the notice of this office immediately.**


