The tender forms can be obtained against payment of **Rs.350/-** (Non refundable) and contractor will be required to produce documents of registration in appropriate class, list of completed works and sales tax registration certificate. The tenders shall be opened in presence of contractor or their authorized representative.

The earnest money in shape of National Saving Certificate/Time deposit account of nationalized saving or Saving Bank account in any of the post offices and F.D.R. of Nationalized Bank duly pledged in favour of the Executive Engineer, NH Division, HP.PWD, Solan must accompany with the tender offer. The exemption from depositing the earnest money with each tender earlier granted has been withdrawn under Govt. Notification No. PWE (B&R)(B)14(18) / 98-11 dated 4.11.2003 and accordingly the tender received without assigning any reasons thereto shall not be entertained.

The tenders will be issued only to them who qualify the criteria after the scrutiny of application Form. The tenders not accompanying the Earnest money shall be rejected at the time of opening. The contractor shall also indicate the detail of Earnest money in the tender document. The request on prescribed application should accompany the registration of appropriate class, sales tax registration No. The tenders shall be opened on schedule date and time in presence of contractor or in the presence of the authorized representative.

The validity of tenders has been given in the tender document. If any contractor/firm withdrawn the offer within validity period then their earnest money shall be forfeited and shall finally be at the disposal of State Govt. The contractors are advised to write the rates both in figures and in words, failing which the tender shall be rejected.

Conditional and incomplete tenders shall out rightly be rejected.

Application for obtaining the tender form must accompany the latest renewal of enlistment and proof of CST No/NOC from Excise and Taxation Department regarding Sale Tax clearance. The offer shall be kept open for 120 days.

If due to any unforeseen reasons the office of the Executive Engineer, NH Division, HP.PWD, Solan remain closed on the notified date of sale and receipt of tender, the tender will be sold and received/opened on next working day of same specified time.
