- Their appointment shall be subject to the production of Medical Certificate of 4. fitness from the District / Medical Officer of the Govt. Hospital.
- They are liable to service in any part / area where HP PWD has its organization. 5.
- They are required to produce all original certificates in support of their qualification / technical education , age, Citizen of India / Himachal Pradesh 6. Bonafide and belonging to any reserved class against which they are proposed to be appointed at the time of joining the post.
- They shall have to submit assets & liability statement. 7.
- They should give a declaration that they have not more than one living spouse. 8.
- They will be governed by the CCS & CCA Conduct Rules. 9.
- 10. The regularization will be with prospective effect i.e. from the date of issue of regularization orders.
- 11. They will required to take oath affirm on the following form.
