The appointment shall subject to the following terms & conditions:-

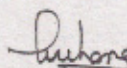
1. He/she will be paid @ Rs. 300/- (Rupees Three Hundred) only per day or as prescribed by the State Govt. from time to time.
2. No travelling allowance will be paid to him/her for joining the post.

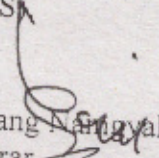
