Before the above orders are implemented, the concerned Head of the office will ensure that the promotee fulfil the appended conditions: -

- 1. The above promotee will join at the place of his posting on promotion within 15 days from the date of issuance of this order failing which the promotion orders shall deemed to be withdrawn automatically for one year or till the date of next D.P.C. whichever is later. No specific orders with reference to withdrawal of promotion will be issued separately.
