**Assignment Title:** *Services for providing and implementing "Vehicle Tracking System "for Monitoring of PMGSY Road Construction in the State of Himachal Pradesh*

The Himachal Pradesh Gram Sadak development Agency, Nirman Bhawan , Nigam Vihar Shimla 171 002 intend to engage a firm which will provide following services for implementing "GPS enabled Vehicle Tracking System (VTS)"for Monitoring of PMGSY Road Construction in the State of Himachal Pradesh. The VTS shall be installed on the equipment which are used during road construction such as tippers, rollers, excavators, motor graders etc. This VTS shall be instrumental in enhancing productivity during construction and improving the quality of work.

The specific objectives of the services are to:
