Before, the above orders are implemented, the concerned Head of the office will ensure that the promotees fulfill the appended condition:-

- 1. That all the Class-IV officials so promoted as Clerk will qualify the typing test with a minimum speed of 25 words per minute in English Typewriting or 20 words per minute in Hindi Typewriting on computer within the probation period which will be conducted by the concerned Departments and the incumbents will get three chances during the probation period. If the candidate fails to qualify the typing test within the prescribed period, his probation period will be extended. During this period the incumbents will get one more chance. If the candidate still fails to qualify the typing test in the extended period, he will be reverted from Clerk to Class-IV.
- 2. The above incumbent will be entitled for the pay scale of Rs:- 20200-64000-Level-3 and their fixation of pay will be done under the provisions of normal Rules.
- 3. Other conditions of service will be governed by the relevant rules/orders in force from time to time.
- 4. The officials posted outside the radius of 25 KM are entitled for TTA/JT.



- The original academic qualification certificate and their validity may 5. also be seen before relieving / accepting the joining of the above promotees.
- The above promotees will join at the place of his /her posting on 6. promotion within 15 days from the date of issuance of this order failing which the promotion order shall be withdrawn automatically for one year or till the date of next D.P.C whichever is later No. specific orders with reference to withdrawal of promotion will be issued separately.
- Before relieving the official to join the new place of posting on 7. promotion it may be ensured the no fresh departmental inquiry /vigilance case is pending against the said officials, if so same may be brought to the notice of this office immediately.
