#OFFICE ORDER#

In pursuance of letter No. PBW-A-B(6)-03/2021 dated 31.08.2022 form the Principal Secretary (PW) to the Govt. of H.P. Shimla-02, reemployment in favour of Sh. Mohan Singh, Work Inspector, to be retired from the Office of Executive Engineer HPPWD NH Division Rampur on 31.12.2021 is hereby offered for a period of six months from 01.09.2022 to 28.02.2023. His re-employment shall be regulated as per the instructions received from the Govt., in this regard vide Special Secretary (Finance) to the Govt. of H.P., Shimla Office Memorandum No. Fin(c)-B(7)-13/2009 dated 23 March 2017.

1. Salary:-

His pay shall be fixed in accordance with the provision of H.P., State Civil Services (Fixation of re-employed pensioners) orders, 1988. O.M. No. Fin(c) B(7)10/84 dated 1st December 1988, O.M. No, Fin-C-B(7)-10/98 dated 8th September, 1999 and read with O.M. No. Fin(c) –B(7)13/2019 dated 19th April, 2010 or as amended from time to time.

2. Tenure:-

The Tenure of appointment shall be for a period of 6 months from 01.09.2022 to 28.02.2023, but the actual benefit of pay and allowance shall be allowed from the date of his joining. Provided that his appointment can be terminated even before the expiry of the above period, in case the conduct and performance is not satisfactory or if the Govt., decides to fill up the post, in the question, by appointment as per R&P Rules, as the case may be.

3. TA/DA:-

He shall be entitled to TA/DA as was admissible to him before his re-employment.

4. Leave:-

The provisions of CCS (leave) Rules, 1972 shall not be applicable to him. He shall not be entitled for LTC/HTLTC facility. He will be entitled to one casual leave for each completed month.

Medical Facilities:-

He shall be entitled to avail medical facilities and grant of re-imbursement of medical Expenses as is admissible under the relevant rules/instructions of the State Government.

6. Residential accommodation:-

He shall be entitled to the allotment of Government Residential accommodations, if the accommodation is available or otherwise he will be entitled to receive House Rent Allowance as per State Govt. Rules and instructions in this regard.

7. Gratuity and Death-cum-Retirement Gratuity:-

He shall not be eligible for Gratuity and Death-cum-Retirement Gratuity for the period of above re-employment.

8. Other Facilities:-

He shall be entitled to the allowances as were admissible to him before his reemployment or admissible for the post against which he has been re-employed. There will be no enhancement in salary on his above re-employment.

9. His head Quarter is hereby fixed in the office of Executive Engineer HPPWD NH Division Rampur.
