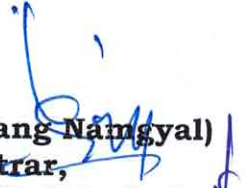

OFFICE ORDER

Consequent upon their promotion to the post of Supdt.Gr.II in the Level 12 of HPCS (Revised Pay) Rules 2022 as issued vide this office orders No. 10112-10131 dated 29/09/2022, the posting orders of Supdt.Gr.II in this department are hereby ordered with immediate effect in the public interest as under:-

The officials posted outside the radius of 25 KM are entitled for TTA/ joining time.

Before the above orders are implemented, the concerned Head of the office will ensure that the promotees fulfil the appended conditions:-

1. The above promotees will join at the place of his/her posting on promotion within 15 days from the date of issuance of this order failing which the promotion orders shall deemed to be withdrawn automatically for one year or till the date of next D.P.C. whichever is later. No specific orders with reference to withdrawal of promotion will be issued separately.
2. No promotee has right to forego the promotion in public interest and promotion can be enforced. However, if someone applies to adduce for refusal of promotion to the appointing authority, he/she will be debarred for one year or up to the next DPC whichever is later. In case of non acceptance of reason to forgo the promotion by the accepting/ appointing authority, he/she will not be considered for promotion in future and shall be debarred forever.
3. The above promotion is subject to review due to any consequential administrative reasons.

4. Those who have been posted outside the sub-cadre/ Tribal area will have to serve in difficult sub-cadre as and when it is administratively required.
5. That in case of any factual error/ omission is detected later on, the promotion orders so issued will be withdrawn and the concerned official shall have no claim for the same. The Controlling Officer will obtain an undertaking to this effect from every promotee before they are relived on promotion to the next station.
6. **Before relieving the official to join the new place of posting on promotion it may be ensured that no fresh departmental inquiry/vigilance case is pending against the said official, if so same may be brought to the notice of this office immediately.**
