MEMORANDUM

Whereas Sh.Rahul Kutleria, S/o Sh.Roshan Lal presently working as Junior Engineer(Elect.) under HPPWD Elect.Divn.Mandi (Elect. Sub Divn. Udaipur) has filed CWP No.6441 of 2022 before Hon'ble High Court which was listed on 15.09.2022 wherein Hon'ble High Court has passed the following order:-

2. *The petitioner admittedly has completed his normal tenure of service in the tribal area having been posted there continuously since his appointment i.e. 23.10.2018 and is thus entitled to be transferred and posted at anyone of the five stations of his choice. The petitioner has already given his options in para-4 of this petition, which are enumerated below:-*
- "(1) Electrical Sub Division, HP PWD Mandi against vacant post or person having longer stay.*  
*(2) Electrical Sub Division, HP PWD Sundernagar against vacant post or person having longer stay.*  
*(3) Electrical Sub Division, HP PWD, SLBSGMC&H Medical College, Nerchowk against vacant posts or person having longer stay.*  
*(4) Electrical Sub Division, Janjehli, District Mandi, H.P.*  
*(5) Electrical Sub Division Kullu, District Kullu, H.P."*
3. *In the given facts and circumstances of the case, we deem it appropriate to dispose of this petition by directing the respondents to consider, decide the case of the petitioner and thereafter issue consequential orders of transfer and posting of the petitioner to anyone of the five stations enumerated above within a period of four weeks from today. Ordered accordingly.*
4. *Pending application(s), if any, also stands disposed of.*  
*For compliance, to come up on 12.10.2022.*
