### #MEMORANDUM#

Whereas, Sh. Lekh Ram, while working as Jr. Tech. (Work Inspceter) in HPPWD B&R Division Sunder Nagar was transferred to HPPWD B&R Division Karsog vide this office order No. PWE-133-9(WI)/2022-ES-III-7339-43 dated 02.09.2022 upon the approval of competent authority vide U.O. No. Secy/CM-17027/2017-VIP-C-433391 dated 30.08.2022. Feeling aggrieved against these orders, Sh. Lekh Ram, Jr. Tech. (Work Inspector) filed CWP No. 6692/2022 titled as Lekh Ram vs State of HP & others before the Hon'ble High Court and same was disposed off on 22.09.2022 with the following directions:-

2). *"The learned counsel for the petitioner states that the petitioner would be satisfied if the petitioner is permitted to make a representation against the impugned office order dated 13.09.2022 (Annexure P-3) to respondent No. 2- the Engineer-in-Chief, HPPWD and if directions are issued to decide the same in a time-bound manner.*

3). *In the circumstances, we dispose of this petitioner by permitting the petitioner to make a representation to respondent No.2. If such a representation is made within four working days from today, the same shall be decided within three weeks from the date of receipt of the representation.*

4). *Until the representation is decided, the petitioner shall not be disturbed from his present place of posting at HPPWD B&R Division Sunder Nagar, Distt. Mandi.*



5). *The writ petitioner to stand disposed of in the above terms, so also the pending miscellaneous application(s), if any."*

Now, in compliance to the direction/judgment passed by the Hon'ble High Court of Himachal Pradesh Shimla, the applicant was called for personal hearing on dated 01.10.2022 vide this office letter No. PWE-133-9(Court Case) -ES-III-2022-8195-98 dated 30.09.2022. In response to this the applicant appeared in



person and made his stand orally as well as in written that his transfer may be cancelled and be retained at same station. After hearing the case, it has been decided that transfer orders of Sh. Lekh Ram Jr. Tech. (Work Inspector) from HPPWD Division Sunder Nagar to HPPWD B&R Division Karsog as issued vide this office order No. 7339-43 dated 02.09.2022 is hereby cancelled with immediate effect in the public interest.


