MEMORANDUM

Whereas, Sh.Raj Kumar S/o Sh. Bharat Chand presently working as Junior Engineer(Civil) under HPPWD B&R Divn. Bharmour has filed CWP No.6875 of 2022 before Hon'ble High Court which was listed on 29.09.2022 wherein Hon'ble High Court has passed the following order:-

2. The petitioner has been serving continuously in a tribal area of Bharmour under HPPWD Sub Division Holi, Distt. Chamba, HP, ever since from his first appointment on 1.8.1997 and in terms of comprehensive guiding principles-2013 for regulating the transfers of State Government employees is entitled to be posted at one of the soft stations of his choice.

3. The petitioner has already made a representation vide Annexure P-4 wherein five stations of his choice have been mentioned.

4. Accordingly, we deem it appropriate to dispose of the instant petition by directing the respondents to consider and decide the representation(Annexure P-4) preferred by the petitioner and thereafter issue consequential orders of transfer of the petitioner within a period of three weeks. Ordered accordingly.

5. Pending application, if any, also stands disposed of.

6. For compliance, to come up on 03.11.2022.

And, whereas, the petitioner has already given his options vide Annexure P-4 of this petition, which are enumerated below:-

1. HPPWD Sub Division Shahpur.
2. HPPWD Sub Division Nurpur.
3. HPPWD Sub Division Suliali.
5. HPPWD Sub Division Chowari.

And whereas, the case of petitioner has been examined and it has been found that in HPPWD Divn. Nurpur, one post of Junior Engineer, Civil is lying vacant. Keeping in view the request made by the petitioner and the directions passed by the




