OFFICE ORDER

On the recommendation of Departmental promotional committee, following Head Draughtsman presently working in the Level 12 of HPCS (Revised Pay) Rules, 2022 are hereby promoted to the post of Circle Head Draughtsman in the Level 13 of HPCS(Revised Pay) Rules, 2022 on regular basis with immediate effect in the public interest:-

In case the above officials desire to fix their pay under FR 22 read with Rule 8 of Himachal Pradesh Civil Services Pay (Revised) Rules, 2022 they are required to exercise their option within one month from their promotion.

Consequent upon their promotion to the post of Circle Head Draughtsman in the Level -13, the posting orders are hereby ordered as under with immediate effect in the public interest:

The officials posted outside the radius of 25 K.M. shall be entitled for TTA/JT.

Before the above orders are implemented, the concerned Head of the office will ensure that the promotees fulfil the appended conditions: -

1. The above promotees will join at the place of his/her posting on promotion within 15 days from the date of issuance of this order failing which the promotion orders shall deemed to be withdrawn automatically for one year.
2. No promotee has right to forgo the promotion in public interest and promotion can be enforced. However, if someone applies to adduce for refusal of promotion to the appointing authority, then during the period of validity of the panel, no fresh offer of appointment on promotion shall be made for to such incumbents for a period of one year from the date of refusal or till a next vacancy arises whichever is later. In case

authority he/she will not be considered for promotion in future and shall be debarred forever.

3. The above promotion is subject to review due to any consequential administrative reasons.
4. Those who have been posted outside the sub-cadre/ Tribal area will have to serve in difficult sub-cadre as and when it is administratively required.
5. That in case of any factual error/ omission is detected later on, the promotion orders so issued will be withdrawn and the concerned official shall have no claim for the same. The Controlling Officer will obtain an undertaking to this effect from every promotee before they are relieved on promotion to the next station.
6. Before relieving the official to join the new place of posting on promotion it may be ensured that no fresh departmental inquiry/vigilance case is pending against the said official.


