- "3. Accordingly, we deem it appropriate to dispose of this petition by directing the respondents to consider and decide the representation of the petitioner and issue consequential orders of transfer to any one of the stations opted by the petitioner in his representation and take a decision within a period of four weeks from today. Ordered accordingly.
- 5. Pending miscellaneous application(s), if any, also stand disposed of.
