MEMORANDUM

Whereas Sh. Deepak Kumar, Junior Engineer (Mech.) while posted under HPPWD Mech. Divn. Rampur (Sub Divn. Kaza) has filed CWP No. 8999/2022 titled as Deepak Kumar V/s State of HP. The matter was lastly listed before Hon'ble High Court on 10.03.2023 wherein following order has been passed:-

"2. The petitioner has admittedly completed his normal tenure of service in hard/tribal area, having served continuously w.e.f. 7.08.2019 at HPPWD Mechanical Sub-Division Kaza, District Lahaul & Spiti, HP and as such, he is entitled to be transferred and posted to one of the soft stations of his choice, as per Comprehensive Guiding Principles, 2013. For this purpose, the petitioner has already made a representation dated 1.10.2022 (Annexure P-2).

3. In the given facts and circumstances of the case, we deem it appropriate to dispose of this petition by directing the respondents to consider and decide the representation of the petitioner and thereafter issue consequential orders of transfer to any one of the stations of his choice as opted by the petitioner in his representation and take a decision within a period of four weeks from today. Ordered accordingly.

4. Pending miscellaneous application(s), if any, also stand disposed of.


