





The Governor, Himachal Pradesh is pleased to order the absorption of Sh. Sunil Kumar of Yol Cantonment Board Khas Yol Dharamshala in the HPPWD, who has already been provisionally placed in PWD by the Deputy Commissioner, Kangra vide OM No. 1 (137)272109/Per dated 28.04.2023, against the post of Assistant Engineer (Civil) in the pay Level-18, i.e., 56100-177500/- by keeping one post of Assistant Engineer (Civil) of direct recruitment quota in abeyance till his promotion/superannuation whichever is earlier, with immediate effect subject to terms and conditions duly accepted by him:-

Terms & Conditions:-

1. The permanent absorption shall be strictly in revised Pay Matrix corresponding to the pre-revised pay scale of the post. In case he is working in higher pay scale/grade pay in the parent cadre as a result of grant of benefits under ACPS, the higher pay scale/grade pay being drawn by him shall be protected on absorption as a measure personal and the difference need not be added in the pay band in accordance with H.P Government Department of Finance (Regulation) letter No. FinC-F(1)2/2012 dated 20th February, 2014.
2. The age of superannuation of the absorbed person from Yol Cantonment Board will be governed as applicable to the Central Government employees.
3. The permanent absorbed person shall continue to draw his annual increments on normal date(s) of increment(s) which he as usual, used to draw in his own pay scales on the posts he held in the lending organization prior to his secondment/absorption in the borrowing office/organization.

4. The absorption will be on temporary basis and the absorbed employee shall remain on probation for a period of 02 years. In case his work and conduct is not found satisfactory during his probation period, it can be extended.
5. The officer being absorbed shall be placed at the bottom of cadre of AE (Civil) and seniority shall be determined on the basis of his absorption in the Department.
6. The pensionary benefits of the official will be regulated as per the instructions of the State Government issued vide FD's letter No. Fin (Pen) A (3)1/97 dated 15.05.2003 and as per the provision of H.P Civil Services Contributory Pension Rules, 2006 notified by the Department of Finance (Pension) vide Notification No. Fin (Pen) A (3)1/96 dated 17.08.2006.
7. In the case of those employees who were appointed on or before 14.05.2003 on regular basis and were governed by the CCS (Pension) Rules, 1972 in their parent organization, then the above condition No. 6 will not be applicable as they shall continue to be governed under aforesaid Rules for pensionary benefits.
8. After absorption, if there is promotion to the next higher post, the incumbent will be promoted as per prevalent R&P Rules.
