  inquiry/ Vigilance case is pending against any one of the above officials. If in any
  case it comes to the notice of controlling officer, the matter may be brought to
  the notice of this office.
- 2. The Contractual appointees so regularized shall be fixed at the minimum of the time scale of the post.
- 3. The regularization shall be subject to verification of character and antecedents, as provided under relevant rules.
- 4. Their appointment shall be subject to the production of Medical Certificate of fitness from the District / Medical Officer of the Govt. Hospital.
- 5. They are liable to service in any part / area where HP PWD has its organization.
- 6. They are required to produce all original certificates in support of their qualification / technical education, age, Citizen of India / Himachal Pradesh Bonafide and belonging to any reserved class against which they are proposed to be appointed at the time of joining the post.
- 7. They shall have to submit assets & liability statement.
- 8. They should give a declaration that they have not more than one living spouse.
- They will be governed by the CCS & CCA Conduct Rules.
